

RATES AND FEES - WASTE TRANSFER STATION

1. For each vehicle entering the Waste Transfer Station for the purpose of unloading "**trees, leaves, grass clippings, garden refuse, metal products etc.**" there shall be a charge as follows:

a.	car	\$15.00
b.	half ton truck	\$15.00
c.	trailer	\$15.00
d.	one ton truck	\$20.00
e.	two and three ton trucks	\$30.00
f.	trucks larger than three ton	\$35.00
g.	trailers over 9 feet long	\$20.00
h.	fridges, freezers, air conditioners and other refrigerant appliances	\$25.00 per item

2. For each vehicle entering the Waste Transfer Station for the purpose of unloading "**household garbage and mixed loads**" there shall be a charge as follows:

a.	car	\$20.00
b.	half ton truck	\$20.00
c.	trailer	\$20.00
d.	one ton truck	\$25.00
e.	two and three ton trucks	\$35.00
f.	trucks larger than three ton	\$40.00
g.	trailers over 9 feet long	\$30.00

3. For each vehicle entering the Waste Transfer Station for the purpose of unloading "**construction/demolition/concrete material**" (not including shingles) there shall be a charge as follows:

a.	car	\$25.00
b.	half ton truck	\$25.00
c.	trailer	\$25.00
d.	one ton truck	\$35.00
e.	two and three ton trucks	\$55.00
f.	trucks larger than three ton	\$65.00
g.	trailers over 9 feet	\$35.00

4. The Waste Transfer Station **does not accept** construction/demolition material from a demolition permitted residential dwellings or demolition permitted non-residential dwelling such as a detached garage etc.

5. For loads of **household garbage** or **construction/demolition material** directed to be dumped into transfer bins is unloaded within the available bunkers for the ease of unloading a dump truck or dump trailer, there shall be an **additional handling charge of \$25.00** over and above the household garbage and or construction/demolition rate.

6. For each vehicle entering the Waste Transfer Station for the purpose of unloading "**water/mud**" from a hydrovac/pump truck there shall be a flat charge of \$25.00.

RATES AND FEES - WASTE TRANSFER STATION SHINGLES

7. For each vehicle entering the Waste Transfer Station for the purpose of unloading "shingles" there shall be a charge as follows:

*The Waste Transfer Station Supervisor has the **final say** when determining the cost of a load that enters the Waste Transfer Station for the purpose of unloading shingles.

Small Shingle Loads (small repairs, sheds etc.)

- a. 10 bundles or less \$60.00

Large Shingle Loads (full homes, commercial buildings, detached garages etc.)

- a. 11 bundles and up

An empty steel shingle bin will be provided at the Waste Transfer Station for a customer to utilize if they choose to haul large shingle loads to the Waste Transfer Station. All costs associated with the steel shingle bin such as but not limited to haulage fee, fuel surcharge, landfill weights, bin rental etc. will be charged back to the customer by invoice.

A deposit in the amount of \$750.00 shall be collected by the Town of Indian Head prior to a customer committing to utilize a steel shingle bin located at the Waste Transfer Station for the purpose of filling with shingles.

If the total cost associated with the steel shingle bin is cheaper than \$750.00, the difference will be refunded back to the customer by the Town of Indian Head. If the total costs associated with the steel shingle bin is greater than \$750.00, the difference will then be invoiced directly to the customer.

- b. Residents of the Town of Indian Head can also rent bins from a Town of Indian Head approved contractor to have a roll off bin delivered directly to a residence within Town. If this option is chosen the Town shall order the bin on the customers behalf to be delivered directly to the address located within Town. The contractor will then talk with the customer directly after the order is made and will invoice the customer directly.
- c. Residents of the Town of Indian Head can also choose to haul their shingles to a Ministry of Environment approved landfill of their choice at their own expense.
